# **Summary**

As a member of the Climate and Sustainable Urbanization (CSU) program, the Program Manager will manage the Paulson Prize for Sustainable Cities, support the Annual Conference for Sustainability, and conduct research as needed to support CSU, the CEO Council, and other programs within the Paulson Institute (PI). Drawing on strong communication, organization and collaboration skills, this person will work with programs and teams across the organization.

# **Responsibilities:**

## 1. Project Management:

- Work with the Managing Director to develop and execute the project strategy, budget, operations and logistics, to ensure the Prize competition's successful progress annually.
- Oversee relationship management with Prize partners, including Chinese partners and media partners (with support from the communications team).
- Maintain relationship with the prestigious Jury Committee; seek advice from the Jury Committee; identify and recommend new jurors.
- Oversee promotional strategy to attract submissions, including content generation for website, social media and marketing materials; Working closely with the Communications team to support audio/video production.
- Proactively build and manage relations with potential applicants and channel partners to encourage high-quality applications.
- Manage applications and respond to applicant inquiries in time.
- Oversee application screening process.
- Prepare applications to be reviewed by the prestigious Jury Committee.
- Manage all Prize-related events, including kick off meetings, jury briefing, and jury site visits.
- Plan and manage the annual Paulson Prize award ceremony (with support from events manager).

#### 2. Research to support PI programs:

- Conduct fact-based research across multiple topic areas with a multi-disciplinary approach as needed to support CSU, CEO Council and cross programs.
- Conduct data analysis in Excel and create presentation materials in PowerPoint.
- Summarize results of research in a concise, informative manner.
- Lend support to other team members as requested.

## 3. Other responsibilities:

- Participate in and make presentations at high-level meetings with Chinese policymakers, academic, business leaders and/or NGOs regarding issues related to climate and sustainable urbanization.
- Play a key role in planning and organizing Pl's annual conference on sustainability by collaborating with team members.
- Lend support as required to PI events including conferences and meetings attended by the Chairman or senior leaders of PI.
